
No.GY/21/HFWD/MSM/e-file/72025/3538/J:- In exercise of the powers conferred by sub-section (1) of section 20 read with section 4 of the Gujarat Professional Medical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj.-3 of 2008), the Government of Gujarat hereby makes the following rules further to amend the Gujarat Professional Nursing and allied Medical Educational Courses (Regulation of Admission and Fixation of Fees) Rules, 2018, namely:-

1. (1) These rules may be called the Gujarat Professional Nursing and Allied Medical Educational Courses (Regulation of Admission and Fixation of Fees) (Amendment) Rules, 2025.
(2) They shall come into force on the date of their publication in the *Official Gazette*.

2. In the Gujarat Professional Nursing and allied Medical Educational Courses (Regulation of Admission and Fixation of Fees) Rules, 2018, in rule 4, for sub-rule (8), the following shall be substituted, namely: -

“(8) A candidate who has passed the qualifying examination after appearing in the supplementary examination conducted by the Board, the best result obtained in either the main examination or the supplementary examination, or alternatively, if the Board gives subject wise final marks separately from the marks given for such subjects in each of the two examinations, then final marks obtained and as may be indicated by the Board shall be considered for the purpose of admission.”
